At PREPARATS MORATO, SL (hereinafter RESTAURANT LA MASIA DE DOMENY) we work to offer you the best possible experience through our products and services. In some cases, it is necessary to collect the information to achieve it. We care about your privacy and we believe we need to be transparent about it.

Therefore, and for the purposes of the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (hereinafter, "GDPR") regarding the protection of natural persons with regard to the processing of personal data and the free movement of such data, and LAW 34/2002, of 11 July, Services of the Information Society and Electronic Commerce (hereinafter, "LSSI", RESTAURANT LA MASIA DE

DOMENY informs the user that, as responsible for the treatment, it will incorporate the

personal data provided by users in an automated file.

What personal data do we collect?

The personal data that the user can provide:

- Name, address and date of birth.

- Telephone number and email address.

- Location.

- Information on payments and returns.

- IP address, date and time when you have accessed our services, internet browser that

you use and data about the operating system of the device.

– Any other information or data that you decide to share with us.

In some cases, it is mandatory to complement the registration form to access and enjoy

certain services offered on the website; Likewise, not providing the requested personal

data or not accepting this data protection policy means that it is impossible to subscribe,

register or participate in any of the promotions in which personal data is requested.

Why and why do we process your data?

At RESTAURANT LA MASIA DE DOMENY we process the information provided by

interested parties for the following purposes:

- Manage orders or contract any of our services, either online or in physical stores.
- Manage the sending of the information requested.
- Develop commercial actions and carry out the maintenance and management of the relationship with the user, as well as the management of the services offered through the website and information tasks, being able to carry out automatic assessments, obtaining profiles and segmentation tasks of customers in order to customize the treatment according to their characteristics and needs and better the online experience of the client.
- Develop and manage contests, raffles or other promotional activities that may be organized.

In some cases it will be necessary to provide information to the authorities or third companies for auditing reasons, as well as to handle personal data of invoices, contracts and documents to respond to customer or public administration claims.

We inform you that the personal data obtained as a result of your registration as a user will be part of the Registry of Processing Activities and Operations (RAT), which will be updated periodically in accordance with the provisions of the GDPR.

What is the legitimacy for the processing of your data?

The processing of your data can be based on the following legal bases:

- Consent of the interested party for the contracting of services and products, for contact forms, requests for information or registration in e-newsletters.
- Legitimate interest in the processing of our clients' data in direct marketing actions and express consent of the interested party for everything related to automatic valuations and profiling.

 Compliance with legal obligations for fraud prevention, communication with public authorities and claims of third parties.

How long do we keep your data?

The processing of the data for the purposes described will be maintained for the time necessary to comply with the purpose of its collection (for example, for the duration of the commercial relationship), as well as for the fulfillment of the legal obligations arising from the processing of the data.

To which recipients are your data communicated?

In some cases, only when necessary, RESTAURANT LA MASIA DE DOMENY will provide user data to third parties. However, the data will never be sold to third parties. External service providers (for example, payment providers or delivery companies with which RESTAURANT LA MASIA DE DOMENY works may use the data to provide the corresponding services, without prejudice to this, they will not use the information for their own purposes or for transfer to third parties.

RESTAURANT LA MASIA DE DOMENY seeks to guarantee the security of personal data when sent outside the company and ensures that third party service providers respect confidentiality and have adequate measures to protect personal data. These third parties are obliged to ensure that the information is processed in accordance with data privacy regulations.

In some cases, the law may require that personal data be disclosed to public bodies or other parties, only what is strictly necessary for compliance with these legal obligations will be disclosed.

The personal data obtained may also be shared with other companies in the group.

Where is your data stored?

In general, the data is stored within the EU. The data sent to third parties that do not belong to the EU, we will ensure that they offer a sufficient level of protection, either because they have Binding Corporate Standards (BCR) or because they have adhered to the "Privacy Shield".

What rights do you attend and how can you exercise them?

By virtue of the provisions of the GDPR, you can request:

- Right of access: you can request information about the personal data that we have about you.
- Right of rectification: you can communicate any change in your personal data.
- Right of deletion and forgetting: you can request the prior deletion of personal data.
- Right of limitation to processing: it implies the restriction of the processing of personal data.
- Right of opposition: you can withdraw the consent of the processing of the data,
 opposing the fact that they are still being processed.
- Right to portability: in some cases, you can request a copy of the personal data in a structured, commonly used and mechanically readable format for transmission to another controller.
- Right not to be subject to individualized decisions: you can request that no decisions
 be made based solely on automated processing, including profiling, that produces legal
 effects or significantly affects the interested party.

In some cases, the request may be rejected if it requests that data necessary for compliance with legal obligations be deleted.

Likewise, if you have any complaints about the processing of the data, you can file a claim with the data protection authority.

Who is responsible for the accuracy and veracity of the data provided?

The user is solely responsible for the veracity and correctness of the data included, exonerating RESTAURANT LA MASIA DE DOMENY from any responsibility in this regard. Users guarantee and respond, in any case, the accuracy, validity and authenticity of the personal data provided, and undertake to keep them duly updated. The user agrees to provide complete and correct information on the registration or subscription form. RESTAURANT LA MASIA DE DOMENY reserves the right to terminate the contracted services that have been held with users, in the event that the data provided are false, incomplete inaccurate or out of date.

RESTAURANT LA MASIA DE DOMENY is not responsible for the veracity of the information that is not of own elaboration and of those indicated other source, so neither assumes any responsibility with regard to hypothetical damages that could originate by the use of this information.

How do we process the personal data of minors?

However, in the event that any of them is addressed to minors under fourteen years of age, in accordance with article 8 of the GDPR and article 7 of LO 3/2018, of 5 December (LOPDGDD), RESTAURANT LA MASIA DE DOMENY will require the valid, free, unequivocal, specific and informed consent of the legal guardians to process the personal data of minors. In this case, the DNI or other form of identification of the person who consents will be required.

In the case of people over fourteen years of age, the data may be processed with the consent of the user, except in those cases in which the Law requires the assistance of the holders of the parental authority or guardianship.

What security measures do we apply to protect your personal data?

RESTAURANT LA MASIA DE DOMENY has adopted the legally required levels of security for the protection of personal data, and seeks to install those other additional means and technical measures at its disposal to avoid the loss, misuse, alteration, unauthorized access and theft of the personal data provided to RESTAURANT LA MASIA DE DOMENY.

RESTAURANT LA MASIA DE DOMENY is not responsible for hypothetical damages that may arise from interferences, omissions, interruptions, computer viruses, telephone breakdowns or disconnections in the operational operation of this electronic system, caused by reasons beyond THE CONTROL OF RESTAURANT LA MASIA DE DOMENY; delays or blockages in the use of this electronic system caused by science or overloads of telephone lines or overloads in the Data Process Center, the Internet system or other
